However we were able to calmly address issues raised by the media and the public. An amicable agreement was reached and announced on June 15, 2009. The Idaho Fry Company is now the Boise Fry Company, and we have offered to continue to work with this new restaurant and wish them success. The IPC will continue to represent your interests in protecting your valuable marks.
